### Criteria

Selection criteria includes a combination of the following:

- ▶ Creative solutions or innovations
- ▶ Standards of customer service
- ▶ Community/Charitable Activities/Relationships
- ▶ Peer Interaction/Recommendations

### Categories

Top honors will be awarded by the IPI Professional Recognition Committee in each of these categories:

- ▶ **Parking Staff Member of the Year**  
For front-line staff
- ▶ **Parking Supervisor of the Year**  
For those who supervise one or more employees within a parking/transportation department or unit.
- ▶ **Parking Professional of the Year**  
For management/supervisory staff that directs an entire parking/transportation operation or manages multiple units within a department.
- ▶ **Parking Organization of the Year**  
For public or private parking organizations, departments, consultants, suppliers, commercial operators, etc.
